

FELONIES AND MISDEMEANORS.

Criminal law is divided into two main categories: felony and misdemeanor. Felonies are criminal offenses that carry a minimum penalty of more than one year incarceration. Felonies include: Murder, Aggravated Battery, Weapons Offenses, Arson, Sexual Assault, and Armed Robbery. Misdemeanors include: Public Intoxication, DUI, Speeding, Trespassing, and Vandalism

Drug crimes are one of the most common criminal charges, and the drug laws in Illinois are very stringent. While penalties vary depending on the amount and type of drugs, convictions often carry harsh penalties, including lengthy incarceration, substantial fines, and strict probation.
